

On August 5, 2023, Rachel Hanna Morin was reported missing by her boyfriend, Richard Tobin. Tobin advised that Morin had gone for a walk on the Ma and Pa trail earlier that evening and never returned home. Morin's car was then found at the trail parking lot at the Williams Street entrance in Bel Air, MD 21014. Later the next afternoon, Morin was located deceased a short distance from the parking lot and just off the trail in a wooded area. There were signs that Morin had been beaten to death and sexually assaulted. Morin was partially naked with her sports bra pulled up over her breasts and her shorts pulled down to her ankles. Forensic evidence swabs were collected from multiple areas of Morin's body, to include her vaginal area, and later processed, at which time it was determined that there was genetic material from an unknown male, present inside Morin's vagina.

The Office of the Chief Medical Examiner for the state of Maryland determined that Morin's death was a homicide.

During the course of the investigation, forensic evidence, to include the unknown genetic material and other Deoxyribonucleic Acid (DNA), was recovered from multiple areas of Morin's body. A genetic profile was generated from all the samples and indicated that all were from the same male contributor. Additional DNA testing was conducted, which resulted in identifying a possible relative of the suspect. Subsequent investigation into the family linage, lead to the identification of Victor Antonio Martinez Hernandez (H/M/09-19-2000) as the possible suspect. On June 13, 2024, while interviewing these family members, detectives were advised that Victor Hernandez had been staying with them, in Maryland, from December of 2023 to May of 2024. The family also stated that Victor Hernandez had left around the beginning of May 2024 and never returned. When asked if he left any belongings, the family provided detectives with two bags of clothing and a pair of shoes. DNA swabs were recovered from some of these items and processed at the Maryland State Police Forensics lab. At this time, the lab has advised that the DNA recovered from the clothing, identified by family to be Victor Hernandez's, matched the DNA recovered from the crime scene.
